OFFICE ORDER

It is informed to all concerned that subsequent to the issue of the Office Order vide F.No. JH/RO/BOM/Corres/2023/ICOR/09, dated 19th January 2024 (**copy enclosed**) regarding the completion of tenure of Dr. G.N. Qazi, the matter regarding the misuse of position and irregularities committed by Dr. G.N. Qazi, former Vice Chancellor of Jamia Hamdard and as Director General, Hamdard Institute of Medical Sciences & Research (HIMSR), Jamia Hamdard was considered by the Executive Council in its 70th Meeting held on 27.02.2025 under item No. 70 (7).

- 2. The Executive Council took note of the observations/ findings of the EC Sub Committee and the large scale violations of the UGC Regulations and University Byelaws/ MOA at the hands of Dr. G.N. Qazi and misusing his dominant position as former Vice Chancellor. The members of the Executive Council prima facie felt that Dr. G. N. Qazi has acted in a way prejudicial to the interest of the Jamia Hamdard as well as HIMSR being an institution created by the Jamia Hamdard.
- 3. The Executive Council after due consideration of the findings of the Sub-Committee of the Executive Council and in order to protect the interest of the Jamia Hamdard, the EC resolved that the entry of Dr. Ghulam Nabi Qazi in the University campus should not be allowed and in the event if he enters the Jamia Hamdard campus the same will be treated as trespassing. Appropriate action shall be initiated against him as per law.
- 4. The **EC further resolved** that both Dr. Ghulam Nabi Qazi and Dr. Firdous A. Wani should not be associated with any university work in the future because of their past conduct and breach of trust as Officers of the Jamia Hamdard.
